Northshore Hamilton PDA Proposed Development Scheme amendment

OCTOBER 2021

Economic Development Queensland (EDQ) is the delegated plan making authority for the Northshore Hamilton Priority Development Area (PDA). To ensure the planning for the area is up to date and operates effectively, a proposed development scheme amendment has been prepared and is now available for public comment. A draft Development Charges and Offset Plan (DCOP), which supports the proposed development scheme amendment, has also been prepared.

About the Northshore Hamilton PDA

The Northshore Hamilton PDA comprises 304 hectares and is being transformed into a vibrant mixed-use precinct adjoining the Brisbane River, approximately six kilometres from the Brisbane CBD. The Northshore Hamilton PDA Development Scheme came into effect on 3 July 2009.

About the proposed development scheme amendment

In 2016, EDQ commenced a review of the Northshore Hamilton PDA Development Scheme.

The scope of the review included examining:

- the vision for the PDA to ensure it is contemporary and appropriate
- land use and infrastructure planning to support the vision
- development requirements to guide new development
- the views of the community, Brisbane City Council, State Agencies and other stakeholders regarding the future of development within the PDA.

The review has resulted in the preparation of a proposed development scheme amendment and a draft DCOP. The draft DCOP addresses the planning and funding of infrastructure required to service development in the Northshore Hamilton PDA.

The structure plan in the proposed development scheme amendment is located on the back of this newsletter.

How to view the proposed development scheme amendment and draft DCOP

EDQ encourages all interested parties and stakeholders to view the proposed development scheme amendment and draft DCOP and provide feedback.

The proposed development scheme amendment and draft DCOP will be publicly notified for 30 business days from Friday 22 October until Friday 3 December 2021.


